F. Activities Accomplished in 2011:

- Managed park maintenance activities in historic district including the public beach
- 2. Administered Park Plan.
- 3. Continued to distribute Frontenac Historic District Resource Guide.
- 4. Worked with Christ Church Preservation Partners to develop the Christ Church restoration plan, develop their website, and pursue public grants.
- 5. Maintained web site for public access to agenda, minutes, design review applications, contact information, and a pictorial history chronology.
- 6. Reviewed design review applications
- 7. Conducted discussions with Friends of the Florence Township Town Hall and advanced the application process to establish the Town Hall as a Historic District.
- 8. Repaired park benches at scenic overlook vistas.
- 9. Worked with Florence Township Planning Commission and the township supervisors to draft a Township Park Board Commission that is responsible for all the parkland in Florence Township.
- 10. Encouraged and supported Township moratorium on silica mining.

G. Future Projects

- 1. Complete plans to establish Florence Township Town Hall as an historic district.
- 2. Draft and gain public approval of a revised heritage preservation ordinance that adds the Florence Town Hall Historic District and removes management of the public park lands and draft changes to the commission bylaws to administrate the revised ordinance.
- 3. Draft an ordinance and bylaws for a new Florence Township Parks
 Commission and work with the Florence Township Planning Commission
 and the Florence Township Board of Supervisors to gain public approval for
 the Parks Commission
- 4. Maintain and enhance the HPC web site.
- 5. Assist Town Supervisors in creating a Florence Township Park Board.
- 6. Work with Board of Supervisors to install new street signs throughout the Frontenac historic district.
- 7. Partner in the grant solicitation efforts for the restoration of Christ Episcopal Church.
- 8. Work with the Board of Supervisors to set an increased budget for improved maintenance of public lands in the historic district to include the roadway boulevards and parks.
- 9. Fund, select, install, and manage additional park benches in our Park Bench Sponsorship program.
- 10. Host a Preservation Day program that focuses on the Christ Episcopal Church restoration project.
- 11. Process Design Review applications.
