The treasurer's report is as follows: A beginning checking and money market balance of \$565,057.41, receipts of \$611.65, disbursements of \$21,886.84 for a total checking and money market balance of \$543,782.22. We still have the one CD for \$88,425.36 for a total cash and investments of \$632,207.58. There was a motion made and second to approve as presented. The motion passed.

Zoning permit: John Stutsman build a new house in Old Frontenac They have planning commission and HPC approval. There was a motion made and second to approve as presented. The motion passed.

Parks -We have made a survey for residents about how we should use the park property. We are going to walk the steamboat landing next month.
